Detailed Get Dressed Privacy Policy

Summary

Protecting your privacy and the confidentiality of your personal information has always been a part of the way we do business at Get Dressed Clothing Inc., "Get Dressed". We believe in protecting the privacy of the personal information that we obtain for business purposes about our customers, employees, suppliers and other entities.

Get Dressed, will take reasonable steps to protect your personal information in accordance with this privacy policy and applicable law. We will not sell nor rent nor give away your information to third parties. However, we do use any personal information you provide to us for marketing and analysis purposes.

What is Personal Information?

"Personal Information" means information about an identifiable individual, but does not include the name, title or business address or telephone number of an employee of an organization.

What Personal Information do we collect?

Get Dressed uses information collected at the point of sale, and through our website to improve our designs and keep in contact with our customers. In order to do this, we often ask to collect your name, mailing address, email address and telephone number at the point of sale. Payment information may be collected for the purpose of processing your order, receiving payment of the same, and analysis in individually unidentifiable, aggregated reports.

How do we collect Personal Information?

Get Dressed collects personal information which you provide to us voluntarily, for example: at the point of sale in our stores, on sign-up forms on our website, in queries or complaints, in participation in one of our contests, or surveys.

Get Dressed may obtain your personal information from third parties, such as our marketing partners in order to serve you better, to improve our products and services, to develop and advance the business system of Get Dressed and to ensure complete customer satisfaction. Get Dressed complies with this privacy policy and all applicable privacy laws in the collection, use, disclosure and protection of all personal information that it receives. Any entity with which or from whom we share personal information is required to comply with all applicable privacy laws.

How do we use Personal Information?

Internal Business Purposes

Get Dressed uses the personal information you provide for the purposes for which it was provided, for example to communicate our offers and events to you; to respond to queries or complaints; to notify you that you have won a prize, contest or sweepstakes. Get Dressed uses your Personal Information to better understand your needs, to improve our products and services, to develop and advance the business system of Get Dressed and to ensure better customer satisfaction.

Get Dressed Direct Marketing

Get Dressed may use your personal information for contacting you about products and services, special offers and upcoming promotions or events offered by us, or our marketing partners that we think may be of interest to you for the purposes of marketing. If you prefer that we not use your personal information for direct marketing, you may opt-out of such uses by sending an email to: info@getdressed.ca. Any subsequent registration or request may void your prior elections to opt out of receiving marketing materials from Get Dressed.

When and how do we disclose your Personal Information?

Get Dressed utilizes third party suppliers, vendors and service providers to undertake various tasks on our behalf, such as analyzing and sorting data, removing repetitive information from customer lists, and hosting and maintaining databases. These organizations may have access to personal information to the extent needed to perform their functions, but they may not use it for other purposes, such as marketing their products and services to you or providing your information to third parties. Get Dressed may, for the purposes of its business transactions, share personal information with its professional advisors, suppliers, or agencies. Any entity with which we share personal information is required to comply with all applicable privacy laws. Get Dressed does not sell your personal information.

Where permitted or required by law, Get Dressed may collect, use or disclose your personal information without your consent, for example to comply with a subpoena or warrant issued or an order made by a court, to collect a debt you owe to us.

How do you consent?

By providing us with your personal information, you consent to our collection, use and disclosure of that information as described in this Privacy Policy as amended from time to time or as described at or before the time of collection, use or disclosure, as the case may be.

How do we protect?

We will protect your information with appropriate safeguards and security measures. We have implemented physical, technological and organizational procedures designed to protect the integrity and security of your personal information based on the nature, sensitivity and format of the personal information collected, used, stored or disclosed by Get Dressed. We will retain your personal information only for the time it is required and for the purposes for which it was collected. Only employees and agents of Get Dressed who need to access your personal information in the course of their duties will have access to it.

How can you Correct, View, or Remove Your Personal Information?

We will make every reasonable effort to keep personal information as complete, accurate and current as is necessary to fulfill the purpose(s) for which it was collected.

If you prefer that we remove your personal information from our systems, or if you wish to verify or view such information, send a request via email to info@getdressed.ca

We will respond to your request within a reasonable time, at minimal or no cost. Please note that we may not be able to provide personal information found on you which contains references to third parties as well as information that is subject to legal privilege, contains confidential information proprietary to Get Dressed, related to an investigation of a breach of an agreement or a contravention of the law, or cannot be disclosed for other legal reasons.
